Please also note the following important details related to overnight reservations at the Perdido Beach Resort:

- The Perdido Beach Resort will allow guests the right to cancel their individual guest room reservation without penalty up to **72 hours prior to arrival**. Based on contracted billing arrangements, the Resort will charge the individuals' credit card one night rate for any reservation cancelled within the 72 hours of arrival or upon the guests' failure to check in. "No show" rooms will be held until 9:00am the day following the arrival date on the reservation. After that time, any remaining nights of a "no show" reservation will be cancelled.
